### **BREEDERS PAGE APPLICATION FORM**

To be included on the Breeders Page, you must first be a member of SABCCI. For those not already a member, an application form is available online at [www.sabcci.com](http://www.sabcci.com). Existing members may proceed with the form as set out below. There is an annual charge of €25.00 for inclusion on the Breeders Page, which money is used solely for the advertising and promotion of the Breeders Page and the Club. The initial set-up fee for new members is complimentary, but for lapsed members wishing to re-new there is a €20.00 charge to cover re-uploading expenses. Please read the following notes before completing the form:

<b>STUD</b>	Under 'STUD', if you have a stud cat(s) please indicate whether it is public, private or limited and indicate the breed(s).
<b>KITTENS</b>	Please indicate if kittens are currently available or indicate 'No', 'Please Enquire', 'Now Booking' or other.
<b>LOGO</b>	If you have a logo and wish it to be included with your entry, please forward it as an attachment to <a href="mailto:tony@sabcci.com">tony@sabcci.com</a> in either a .gif or .jpg format. We regret that we cannot accept hard copy/printed logos.
<b>PHONE/ FAX</b>	It is very helpful for people enquiring if you indicate the dialling codes from both the Republic and the North of Ireland.
<b>IMPORTANT NOTICE</b>	It is a condition for inclusion on the SABCCI Breeders Page that all kittens sold as pedigree animals by breeders through the Club website must first be registered with either the GCCFI (for breeders domiciled in the Republic of Ireland) or the GCCF (for breeders domiciled in Northern Ireland or Great Britain). Please note that in the event that it is found that a Breeder Member has failed to register their litter(s) with the GCCFI/GCCF, their listing on the Breeders Page shall be removed immediately and without prior notice to that Member. Please refer to the detailed conditions on Page 2 of this application form.

## **Re: S.A.B.C.C.I. Breeders Page**

Dear Member,

The S.A.B.C.C.I Website has a Breeder's Page which offers Breeder Members the opportunity to list their Cattery and Contact Details to facilitate potential kitten sales from members of the public searching for a particular breed of kitten. There is an annual fee of €25.00 for inclusion on the Breeders Page, this fee is used solely for the advertising and promotion of the Breeders Page and the Club. Entry onto the Breeder's Page is at the discretion of the S.A.B.C.C.I Committee.

However, we wish to remind members that as SABCCI is a G.C.C.F.I affiliated Cat Club, there is a strict condition that inclusion on the Breeder's Page is solely for those Breeders whose litters are registered with the G.C.C.F.I *in the first instance* and not to another Registration Body, such as T.I.C.A., F.I.F.E, C.F.A etc. Please note that in the event that it is found that a Breeder Member has failed to register their litter(s) with the G.C.C.F.I, their listing on the Breeder's Page shall be removed immediately and without prior notice to that Member.

It should also be noted that entry onto the Breeder's Page is neither an Endorsement by S.A.B.C.C.I of any particular Breeder or a Guarantee by S.A.B.C.C.I of the health and temperament of any potential kitten(s). Furthermore, S.A.B.C.C.I will not be held responsible for any loss or damage howsoever arising as a result of the entry on the S.A.B.C.C.I Breeder's Page. This Indemnity shall be made very clear on the S.A.B.C.C.I website, and potential kitten buyers shall be directed to the G.C.C.F.I Code of Ethics for Breeders and Owners and strongly advised to make their own prudent enquiries in relation to the health, temperament and well being of the kitten and also the reputation of the Breeder, prior to any purchase.

S.A.B.C.C.I also reserves the right to investigate and if necessary forward any complaints received in relation to any Breeder or Kitten sale to the G.C.C.F.I.

The S.A.B.C.C.I. Breeder's Page is extremely successful and has generated fantastic feedback, interest and sales from the website's visitors and potential kitten enquirers alike. To that end, S.A.B.C.C.I. remains committed to continue to host the page long into the future and we trust that the Members who are included or wish to be included on the Breeders Page, abide by the above rules in order to protect members of the public, the integrity of S.A.B.C.C.I and abide by the Code of Ethics of the G.C.C.F.I.
